How do I start?

Provide us with evidence of your experience. Simply, email or post to us copies of the following:-

- A completed Recognition of Prior Learning (RPL) Application form
- Current Certificate of Registration
- CPD participation certificates
- Letter of employment from your current employer or appropriate references
- Copies of the following documents:
 - Appraisal report - this can be a letter advising a vendor of your appraisal results
 - Listing report – this can be listing documentation completed by you
 - Leasing documentation
 - Selling report – this can be letters of offers made, letters advising of exchange and completion to settlement
 - Marketing examples – this can be copies of internet, print, letterbox drop marketing etc
 - Evidence of attending tribunals
 - Property maintenance plan
- Any academic transcripts you may have

Is online learning for you?

Online learning is different in many respects from the traditional face-to-face learning we're all used to, primarily in the way we get our information and how we interact with facilitators. Online learners should be comfortable with internet browsing/searching, email, sending and reading attachments and word processing.
